

## **RMA Announces 2015 STAX/SCO Final County Yields**

The USDA Risk Management Agency released the 2015 Upland Cotton county yields that will be used to calculate final county revenue amounts and 2015 Stacked Income Protection Plan (STAX) payment amounts for Upland Cotton.

Initial review of the yields reported for Texas indicates that 46 Texas counties should trigger STAX indemnity payments on participating irrigated acres and 56 counties are expected to trigger non-irrigated STAX payments for the 2015 crop year. This count is determined based on STAX coverage purchased with a 90 percent revenue trigger.

A grower's final STAX indemnity payment will be determined based on that individual's selected revenue trigger, coverage band and the STAX protection factor. Growers could elect revenue trigger points from 75-90 percent, coverage bands ranging from 5-20 percent of the county's expected revenue amount, and a protection factor between 0.8 – 1.2.

On the Texas High Plains, only one county, Deaf Smith, in PCG's 41-county service area appears to have met the 90 percent revenue trigger point on non-irrigated cotton. Based on the figures provided by USDA RMA the calculated STAX payment rate for Deaf Smith non-irrigated cotton would be \$20.63 per acre using a 1.0 protection factor. Growers electing to upgrade their STAX coverage with the maximum allowed 1.2 protection factor would see a maximum possible STAX payment of \$24.75.

On the irrigated side of the ledger, a total of seven PCG counties in the PCG service area are expected to trigger payments under the 2015 STAX policy. Those counties are: Andrews, Crosby, Dickens, Garza, Hale, Motley, and Parmer.

Irrigated payment rates in these counties calculated using the baseline 1.0 protection factor would be: Andrews - \$60.03, Crosby - \$37.31, Dickens - \$42.68, Garza - \$5.53, Hale - \$8.59, Motley - \$63.65, and Parmer - \$17.71. The range of payment rates indicates the variability in irrigated yields across these counties.

The maximum potential STAX irrigated payment rates in these counties calculated using the 1.2 protection factor would be: Andrews - \$72.04, Crosby - \$44.78, Dickens - \$51.21, Garza - \$6.63, Hale - \$10.30, Motley - \$76.38, and Parmer - \$21.25.

Statewide baseline STAX payment rates using the 1.0 protection factor ranged from a low of \$5.53 in Garza County to a high of \$179.97 in La Salle County on irrigated cotton. Dryland cotton payment rates ranged from a low of \$1.19 in McCulloch County to a high of \$104.70 in Bowie County.
